## Treasurer's Report by Shelia Brown

Forest Oaks has 223 residences and 2 empty lots. As of this report, 120 have paid the minimum HOA dues of \$50.00 per year. We have a small number of residents who increase their contribution. Some of those double the amount and some exceed that level. Without the generosity of a few, we would not be able to meet our budget obligations throughout the year. Take a moment to consider that the \$50.00 annual dues is roughly the cost for a family to eat out just once. Information on our financials will be presented at the February HOA meeting .

In the last few years we have been able to increase the beauty of our entrance with more perennial plants and the Christmas decorations. These just keep getting better every year. This year we will change out several original streetlights from wooden to decorative. These changes and our ongoing sidewalk repair initiative help keep our neighborhood beautiful and desirable. (Editor's note: Street lights AND electricity, 1/3 cost of sidewalk repairs, 100% cost of entry upkeep and Christmas lights are paid by YOUR FOHOA dues.)

Here's what I'd like to share with all the residents of Forest Oaks. We're working with almost the same amount of money we collected 5 years ago! We could do so much more if we had more participants.

Think about asking your neighbor if they are a member of the HOA. If not, encourage them to join.

If you haven't paid, please take a moment to use our PayPal account which can be found on our website at fohoa.com and click on the "Pay Dues" tab. \$50.00 paid by EVERY homeowner provides the HOA the necessary funds to keep the entrance updated and beautiful, make repairs, mow and provide salt when needed for ice and snow events. ### Ways to Keep Forest Oaks a Great Place to Live

# WHY YOU SHOULD NOT BLOW LEAVES AND GRASS CLIPPINGS INTO THE STREET!

The City of Edmond provided this information to us from their department of Code Enforcement.

Here are some reasons why this is not the best practice for dealing with yard wastes.

The leaves or grass clippings are a safety hazard. Because there is no way of knowing the road conditions under the leaves, bicyclists that use this route are forced to go out into the driving lanes to pass this obstacle.

An act as simple as blowing grass or leaves into the roadway can have a huge impact on you, your lawn care company, and any motorcyclist who may slip on grass or leaves you sent into the road. You could be sued for negligence if an accident occurs.

The waste can block storm drains. Try watching a storm drain inlet covered in leaves in a rainstorm. It only takes a few leaves to back up the water into a large puddle. This creates nuisance flooding and can potentially cause an additional safety hazard. It can even lead to property damage.

Water quality is also affected by the accumulation of decayed leaves in storm drains. Storm water is not treated before it is discharged into Lake Arcadia or our groundwater, so the concentration of nutrients in the leaves has the potential to contribute to algae blooms in the summer.

It is illegal! Fines for this type of offense for a first violation begin at \$260.00

Additionally, blowing or disposing of leaves in a creek is illegal in Edmond.

#### **Recommendations for a Better Forest Oaks**

- If you have a roofer's or remodeler's sign in your yard, please remove it in a timely manner. These signs appear to be "for sale" signs at first glance and are confusing to potential home buyers.
- Be considerate of your neighbors who may want to sell their homes. Keep your yard, street and property cleaned up and in good repair. The appearance of individual homes affects the value of the entire neighborhood.
- Keep vehicles out of the streets as much as possible. Crowded streets are hazardous and devalue neighborhoods.
- If you have a decorative street light in your yard, you are responsible for trimming branches that obscure the light. Please contact an officer of the HOA if you cannot do it.
- For the safety of walkers, please trim tree branches up about 7 feet above the sidewalk. This is the ADA recommendation.

### **Recycling Information**

### **Recycling Tips** Please read for recent changes.

Place your recycling container at the curb by 7:00 a.m. every other Monday.

Place all types of recyclables together without sorting (except shredded paper).

If it looks like rain, close the lid on your container. Wet paper products cannot be recycled.

Rinse plastic and aluminum and remove lids.

Rinse aluminum and metal cans.

Acceptable Recyclable Items – All items should be empty, clean and dry before placing them in your recycling container.

Plastics – Recycle plastics #1 and #2. Look for a number inside the recycling arrows on the bottom of containers.

Metal & Aluminum Cans - Recycle all food and beverage metal cans - steel, tin and bi-metal.

Cardboard, Newspaper and Magazines - Recycle newspaper inserts, catalogues, paperback books, phone books, corrugated cardboard and brochures.

Paper Food Containers - Recycle food boxes, cereal boxes and pasta boxes.

Paper - Recycle envelopes, office paper, junk mail, greeting cards & file folders. Shredded paper should be placed in a paper bag and folded over to close.

### **Other Sanitation Tips**

Place trash cart within 1 foot of curb on scheduled collection day.

Leave 3-foot minimum between cart/other objects and 15 feet from cars.

2<sup>nd</sup> and 3<sup>rd</sup> carts may be obtained for additional monthly charge.

Break down boxes & limbs so they fall freely from cart into truck.

Don't dispose of following in cart: rocks, dirt, concrete, hot fireplace ashes, construction debris, hazardous chemicals, motor oil, liquid paints, explosives, tires, or any material or substance that is harmful to equipment or personnel.

Waste material that does not fit in cart may be placed in blue Edmond city-coded bags (available at several Edmond stores) or scheduled for bulk pick up.

House-side service is available at an additional cost for individuals with a medical reason.

Transfer Station will accept larger items that you can haul yourself. Located off I-35 at Covell Rd (follow signs). Take your utility bill with you for a better rate. Mon-Fri: 8AM-5PM and Sat 8AM-12 noon.
